Altrad secures two new contracts at Total Lindsey Oil Refinery in North Lincolnshire, United Kingdom

The UK & Ireland recently announced the signature of two long term contracts with [Total Lindsey Oil Refinery in North Lincolnshire](#), UK, in support of their operations with an estimated value of £30 million.

The two contracts encompass the supply of access, insulation, painting (AIP) and specialist environmental services, which will be supported by approximately 150 of Altrad's talented people to support the safe and efficient operation of the refinery.

Chris Smith, Maintenance Manager at Lindsey Oil Refinery, said "Altrad proved from their earliest days on site that they shared exactly these values, that have underpinned their year on year improvement in safety and productivity over the last seven years. As one of our key contract partners they have always responded positively to new challenges and we have been able to continually evolve and adapt our contract together. Our decision to expand their scope of supply from AIP to wider site services from the beginning of 2021, followed a rigorous technical and commercial process, but one which has given us confidence that a similar trend of continuous improvement can be achieved during the next phase."

Altrad secures a 4-year, nuclear decommissioning support contract for Magnox in the United Kingdom

The [four-year contract](#), which commenced on the 19th October 2020, will encompass Altrad UK & Ireland providing services at six of the Nuclear Decommissioning Authority (NDA) owned sites.

The contract award builds upon a successful strategic relationship which spans back over fifteen years, during which time Altrad has delivered a range of services including access, asbestos removal, thermal insulation, environmental cleaning, corrosion protection, cladding and minor civil work – such that, on any one day, Altrad have around 140 talented people, delivering critical services on behalf of its client.

"Magnox Ltd are pleased to have awarded a framework contract with Altrad, for a further four years and we look forward to working closely with them to support the delivery of our decommissioning programme in a safe and sustainable manner. Our contract objectives were wholly met by Altrad's approach and their capability, which includes the introduction of further innovation and the delivery of greater efficiency that will be delivered across the NDA owned sites" said Steven Lock – FM Category Manager of Magnox Limited.

Altrad secures a significant contract renewal for an upstream Oil & Gas operator in the United Kingdom, Southern North Sea

The contract, which commenced back in April 2020 and will continue until December 2021, will encompass [Altrad UK & Ireland providing offshore deck operations](#), mechanical, access and scaffolding, thermal insulation and corrosion protection services in support of 45 offshore platforms and two onshore terminals.

The contract award builds upon a successful relationship which spans back over fifteen years, during which time Altrad has extended the scope of services such that on any one day, between 140 and 170 of its talented people, deliver critical services on behalf of its client.

Altrad support the decommissioning of an offshore gas platform

Altrad have supported Worley, and their client Allseas, with a range of services to enable the safe removal of Spirit Energy's 11,000 tonne platform, DP3, at Morecambe Bay in the eastern Irish Sea.

The [decommissioning platform](#) will be lifted and taken back to shore by Allseas' Pioneering Spirit the world's largest construction vessel.
