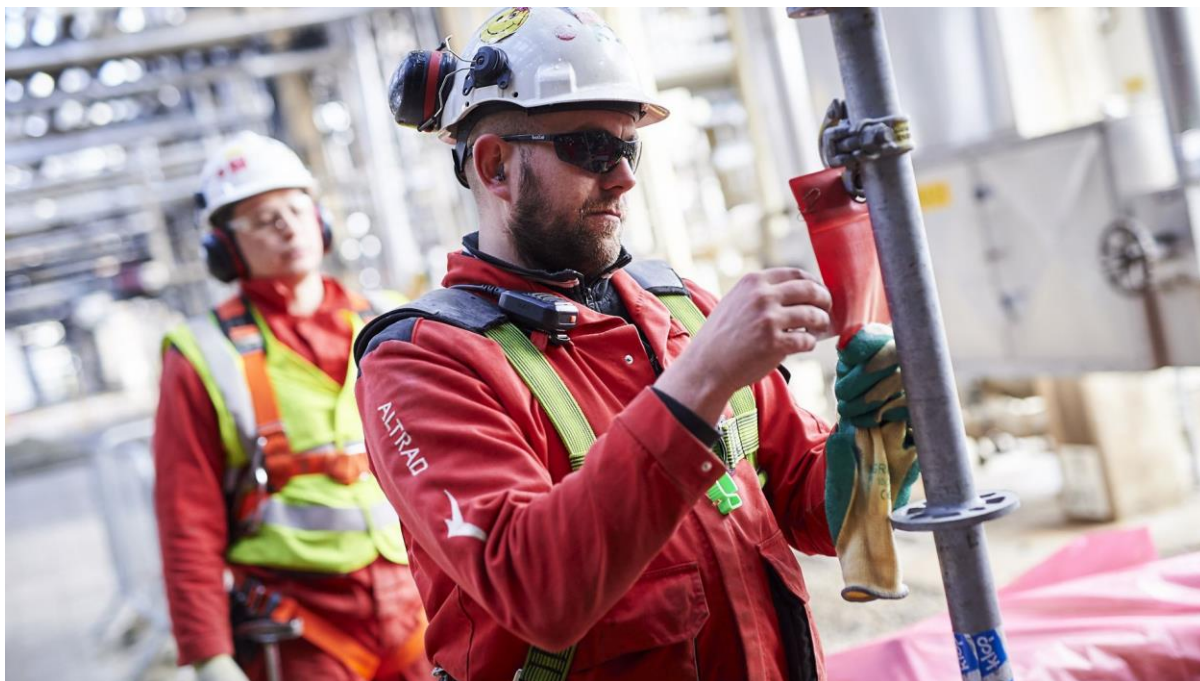


## ALTRAD Arnholdt acquies Les Monteurs de la Brie
